


EU = 63 000 public libraries, CR = 5 400

Library System

- governed by the Ministry of Culture
 - National Library (Prague)
 - Moravian Library (Brno)
 - K. E Macan Library and Printing Shop for the Blinds
- governed by the regional authorities and government departments
 - [Central Specialized Libraries]
 - Regional Libraries ("Research" "Study")
- governed by the local government, selfgovernment, other bodies, institutions
 - all other libraries ("basic", "basic specialized" libraries)

Library Landscape

- 10,5 mil. inhabitants
- 14 Regions = 14 Regional Libraries
- ca 6000 communities => 5354 public libraries in municipalities/communes (2017; 1995: 6179)




Fundamental System Bonds

- 1. Every library must provide prescribed obligatory services.
- 2. Obligatory supply of documents from other libraries by way of ILL.
- 3. Legal Deposit Libraries are obliged to preserve "Conservation Collection" for posterity
 - 3 + 1 (12 = regional) / + 1 Legal Deposit Libraries non-periodicals / visually impaired
 - 5 / 1 Legal Deposit Copies (National Library 2 copies, "regional" copy, vis.impaired)
 - 16 / 1 Legal Deposit Copies for periodical publications
- 4. National Library, Regional and specialized libraries provide other libraries, in the respective field of their activity, with various kinds of education, methodological and standardisation consultation and guidance.
- 5. Libraries may benefit from nation-wide (extended) collective licences (lending of sound recordings, electronic document supply, public readings) negotiated and administered by the National Library.
- 6. National Library is authorised to negotiate with collective management organisations on behalf of the System of Libraries.
